Roles

The Capability Adviser has for each role a separate account:

Assessor

- ✓ Can perform (team) assessments and generate reports
- ✓ Has only access to assessments where he/she is an assessor

Organisation

- ✓ Creates and edits assessments
- ✓ Creates and assigns assessors
- ✓ Tailors domains

Content Provider

- ✓ Adds and imports new process assessment models
- ✓ Edits existing process assessment models

Administrator

- ✓ Create new organization (business unit) accounts
- ✓ Generates benchmarking data
